PRESS RELEASE

The Minister of Finance wishes to inform the general public and economic operators in particular, that, the taxpayers listed below are deemed to be inactive in the taxpayers index of the Directorate General of Taxation as of February 1st, 2024.

In accordance with the provisions of Section 21 (3) of the General Tax Code (GTC), purchases made by the taxpayers concerned from manufacturers or wholesale importers shall be subject to the 10% withholding tax rate.

Conversely, sales or services invoiced by the aforementioned taxpayers shall be non-deductible expenses in determining taxable income for the year, nor shall the related VAT be allowed as a deduction, in light with the provisions of Sections 8 bis (2) and 143 (1-b) of the GTC.
